President's Comments


It is winter and it is QUIET around the lake. I hope the holiday season generated fond memories for each of you.

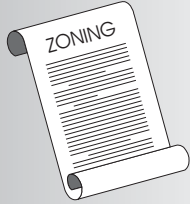
GTC High Voltage Transmission Line

On December 22, environmental groups, as well as several individuals, presented arguments before Senior U.S. District Judge, William C. O'Kelly, requesting that the permit granted to GTC by the U.S. Forest Service to build a transmission line from Tiger to Timpson Creek be withdrawn until the Forest Service prepares an Environmental Impact Statement.

The arguments followed appeals filed in April and Judge O'Kelly is expected to render his decision sometime in January. It is believed his decision will be appealed if it favors allowance of the current permit.



Briefly . . .



- ☑ The Rabun County Commissioners enacted the county's new zoning ordinances on December 23. Thank you for letting the commissioners know that we favored their enactment. The big job – enforcement of the ordinances – now awaits the county's citizenry and the marshal's office. We will report more on this in March.
- ☑ Standpipe locations have been plotted and approved by Georgia Power Company. Construction will soon begin.
- ☑ The real estate development projects around the lake are quiet at this time of year.
- ☑ The *Lake Burton Ecosystem Status Report* is nearing completion and will be enclosed with the March newsletter.
- ☑ LBCA had 912 member families in 2003 – and of that number 78 were listed in the directory as full time residents of the lake.
- ☑ 59 respondents have indicated an interest in high speed Internet access on the lake. In order to provide DSL service, Alltel has to spend a considerable amount of money to upgrade remote switching equipment. We need approximately 25 DSL subscribers served by one of these “remote switches” for DSL to be profitable to Alltel. There are four remote switches serving the lake; therefore, DSL will likely become available in some areas before others – depending on how soon we get a sufficient number of subscribers served by a specific switch. (There are also limitations to how far the DSL signal can be sent from the remote switch to the subscriber.) We are pleased with the response to the notice in our last newsletter, but more subscribers are needed to make this happen. Please mention our efforts to everyone in the area who might be interested in DSL service.
